

Vaccination camp to be held from May 18 onwards at HCL Noida 126 campus

Registration window is now open and will close
on Saturday May 15, 5 pm.



Dear HCLites,

To make the benefits of vaccination available to our employees in a better health environment, we are securing a limited supply of **vaccines**. Starting with Noida, we will subsequently open it in other cities as the supply of vaccines get regulated.

The vaccinations are scheduled to take place from **May 18 onwards at HCL Healthcare clinic, sector 126, Noida.**

Eligibility: Only employees, 18+ years of age, currently residing in NCR region, on a first-come-first-serve basis

- Given limited supplies of vaccines we are opening up this phase for employees only and not dependents or family members.

Steps to Register:

- Firstly, register yourself on the Co-Win portal and keep the CO-Win ID handy till you are vaccinated
- Secondly, [Click Here](#) to enroll yourself for the vaccination.
- **The registration window will be open till Saturday, May 15, 2021, 5 pm.**
- Those of you who are shortlisted will receive an email confirmation and an option to choose from available date and time.
- Those not shortlisted in this phase can re-register in subsequent phases.

Mandatory requirements for vaccination:

- Please carry your **HCL ID card, AADHAR card and soft copy of the email confirming your vaccination appointment** to the vaccination center.
- The standard process at gate entry – **SARAS/Mobiosafe/Aarogya Setu** assessment will apply even if you are coming for vaccination only.
- In light of the above mentioned point, please do not get anyone or family members to accompany you to the vaccination center because **they will not be allowed entry into the premises** and also to ensure there is no crowding.
- Those coming for vaccinations on your day of appointment should head straight to the vaccination clinic and after inoculation they should head out of the premises. Employees should not go to their workstations or any other hang-out areas in the premises, before and after the vaccination.

Exclusions:

Pregnant ladies and lactating mothers

- People with history of reaction to previous dose
- Any kind of immediate or delayed-onset anaphylaxis or allergic reaction to vaccines or injectable therapies, pharmaceutical products, food-items etc. in the past

Provisional / temporary contraindications:

- Persons having active symptoms of SARS-CoV-2 infection.
- SARS-COV-2 patients who have been given anti-SARS-CoV-2 monoclonal antibodies or convalescent plasma.
- Acutely unwell and hospitalized (with or without intensive care) patients due to any illness.
- If you were in home quarantine or giving care to COVID infected family members.

Please note: in such cases, COVID-19 vaccination is to be deferred for 4-8 weeks after recovery. Please wait for the next slot to open and then register accordingly.
